**Fire Safety Suggestions:**

Sl. No.	As Builder	As Occupant	As Security personnel
1.	All the fire protection arrangements shall be maintained in good condition as seen during inspection.	The escape / exit roots shall not be kept locked / blocked or encroached.	All the occupants must know the correct method of operation of the fire fighting system installed
2.	Any loss of life or property due to non-functioning of fire safety measures and other installations shall be the responsibilities of the management.	All occupants shall be trained to operate the fire safety equipment during emergency.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.
3.	Addition / alteration, if any in the building may be verified by building authority.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.	All security personnel shall be trained to operate the fire safety equipment during emergency.
4.	This Annual Periodical Renewal Fire Certificate is only from Fire Safety Point of View.	Raise the alarm If the fire cannot be controlled, evacuate the area completely at once with nearest safe exit.	Attack the fire using available fire equipment only if you feel capable of controlling it. If not, takes all steps to isolate the area by closing doors and windows.

5) This Annual Periodical Renewal Fire Certificate is valid for period of one year from the date of issue of this letter. It is the responsibility of the builder to maintain the Fire Safety Equipment in good working condition at all times and apply for next Annual Periodical Renewal Fire Certificate, duly remitting the User Charges as per G.O.Ms.No.169, Home (Fire) Department, dated 19.12.2019, two (2) months before expiry of this Annual Periodical Renewal Fire Certificate.
